Question: Per project specifications, section 01 14 00 "Existing Conditions," paragraph 1.1.4, "Occupied and Existing Buildings," we are told that "The Government will remove and relocate other government property in the areas of the buildings scheduled to receive work." Is this to mean that the government will remove and relocate the existing furniture located in the sleeping rooms? Please clarify.

Answer: The unoccupied rooms to receive renovations will not contain personal effects items; however, typical BEQ furniture will remain in the rooms. The Contractor shall work around or move furniture within the rooms to facilitate the completion of the renovation.
